

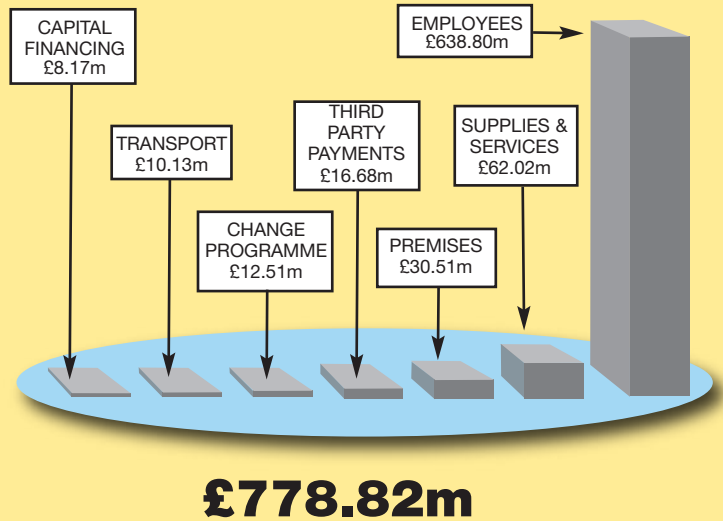

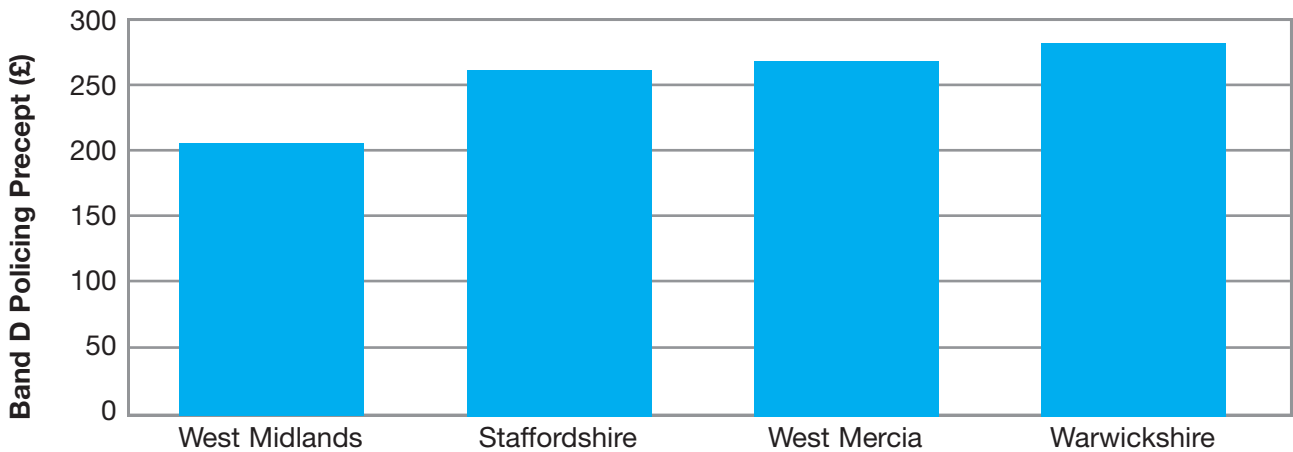

The West Midlands Police budget remains under severe pressure. The total grant settlement for the West Midlands in 23/24 is £569.7 million, which is an increase of £10.3 million on the 22/23 settlement. This grant will enable WMP to maintain police officer numbers during 23/24,

as part of the so called national uplift programme target of 1,200 officers by March 2023 and fund the 22/23 police officer pay award.

Of course, this is welcome. However, it will not replace the 2,221 police officers we lost between 2010 and 2019. WMP will still have 1,000 less police officers than it had in 2010 – whilst at the same time, there are police forces in other parts of the country that now have more police officers, than they have ever previously had in their history.

In addition, Police and Crime Commissioners are expected to pay for the Police Staff 2022 pay award, together with 2023 pay awards and meet rising costs and inflation, from the funding settlement. As part of the budget for 2023/24 West Midlands Police will continue to have to deliver further efficiency savings.

The settlement includes the opportunity for PCC's to raise their precept by up to £15 per year per Band D property in 23/24. This is an increase on the £10 per year, per Band D property, that was announced in

December 2021. The ability to raise the Council Tax police precept by £15 per year, per Band D property – an amount that equates to £1.25 per month - will generate an additional income of £13.2 million. The amount raised per household from the police precept, for a Band D property, will continue to be the second lowest in England.

However, even with the increase in the precept, the savings required to support the revenue budget in 23/24 will be £28.1 million. The effect of this is that the government is to all intents and purposes, mandating an increase in the precept. This also illustrates that the settlement does not maintain the baseline funding that West Midlands Police needs to operate on a day to day basis, to deliver an effective and efficient police service.

The government is determined to continue with its strategy of compelling the people of the West Midlands to pay more local tax, for less local policing. I would much rather that the government had fully funded this increase, rather than effectively mandating it and imposing the burden onto local taxpayers. However, I was elected on a clear mandate to re-build community policing and that is exactly what I am doing. People want preventative, proactive, problem solving and visible policing out on the streets, keeping people, their families and local communities safe and secure.
